APPLICATION INSTRUCTIONS

LandSpring WP is packaged in a plastic container. Open the container with your body upwind. If exposed to water, the formulation will begin to release 1-MCP gas. In poorly vented systems, this gas may temporarily reach frammable levels in the headspace. The headspace must not come in contact with an ignition source.

Rate, time and mode of application: Refer to instructions in crop table.

Plant Safety: This product has been tested on numerous plant varieties with no phytotoxic effects. However, since this product has not been tested on all plant varieties or in combination with all available adjuvants or tank mixes, the manufacturer recommends testing on a small number of plants to check for adverse plant effects before applying on a larger number of plants. Under certain environmental conditions, the use of spray adjuvants can result in transient crop response.

Incompatibility: Do not use with products containing copper.

SEEDLINGS: When applied to seedlings 1-5 days before transplanting, Land Spring WP helps decrease transplant shock enabling plants to more rapidly establish and grow. Observed cenefits include increased crop biomass due to better root and shoot development when plants are structured to stress in the weeks following transplantation.

Mixing Instructions for Sprayer Tanks:

- 1. Fill the tank of application equipment with required water volume
- 2. Add the required LandSpring WP to the tank:as directed in the Use Rate Table above.
- 3. Continue running the agitation system for 3 minutes after adding the LandSpring WP.
- DO NOT EXCEED 3 MINUTES OF AGITATION.
- 4. Do not use agitator during spraying.
- 5. Initiate spray application as soon as possible after step 3 and no later than 15 minutes after preparation of tank mixture.

Mixing Instructions for Dosatron or Other injection systems:

- Fill the tank of application equipment with required water volume.
 Add the required LandSpring WP with tank as directed in the Use Rate Table above.
- 3. Gently stir the spray solution for up to 3 minutes.
- 4. Initiate spray application as soon as possible after step 3 and no later than 15 minutes after preparation of spray mixture.

Spray Volume

Use calibrated equipment to apply LandSpring WP in a sufficient amount of water to ensure good drenching of the seedlings. Product efficacy requires that the foliage receive uniform spray coverage. Use a minimum sphere volume of 40 gallons per acre.

Spray Nozzle Requirements

Required droplet size is 250-400µm. For best results, do not use droplets smaller than 250µm.

Important Considerations

- For best results, apply under slow drying conditions, e.g. early in the morning or at night, in order to ensure adequate absorption.
- The manufacturer recommends to not apply if rain or overhead irrigation is expected within 1 hour • of application.
- The manufacturer recommends to not apply in winds exceeding 10mph. .
- LandSpring WP has a 1 day preharvest interval (PHI) •
- Handle LandSpring WP in a well ventilated area.
- The manufacturer recommends applying LandSpring WP alone on seedlings, without tank mixes or adjuvants.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Store in original packaging in a cool, dry place.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.
